B. PERFORMANCE

1. Programme progress and results

Objectives

The year 2023 was exceptionally turbulent from the perspective of political and societal developments. The state of gender equality in Slovakia is still not balanced. Slovakia ranks 24th in the EU on the EIGE Gender Equality Index. Its score is 12.6 points below the EU's score. In 2022, the gender gap in average nominal monthly earnings was higher than in 2021, up to 19%. Women thus earned 311 euros less monthly on average than men[1]. The high inflation rate has also worsened women's situation in Slovakia. In total, for the eleven months of 2023, consumer prices increased by 11% year-on-year. The most affected were low-income households, which felt a price increase of up to 11.6%[2], and among these, there is a high proportion of households of single mothers with minor children. Together with rising housing prices, whether in the form of commercial rental or owned property and the deficient availability of social or municipal housing, it is reasonable to consider that the social situation for women experiencing violence and their children complicated the way out of violence, especially for those who, as a result of leaving the abuser, face the risk to fall into poverty.

A new government was formed after early parliamentary elections held at the end of September.

In its Program Declaration[3], the new government undertook to ensure "the conditions for the coordination of all state agencies and non-state partners in preventing violence against children, women and other vulnerable groups" and to "implement changes that will lead to improved protection of women and children from domestic violence, effective prosecution and sanctioning of perpetrators of violence against children, perpetrators of sexual exploitation and harassment, including punishment for acts in the online space". Concerning the outputs and activities delivered within the Programme "Domestic and Gender-Based Violence" in 2023, it is clear that inspiration can also be drawn from the programming and implementation of this programme, as far as both state actors and non-governmental organizations are jointly involved into it and they follow the same objective. In addition to the strengthening of capacities and quality of support services to women experiencing violence in intimate partner relationships and victims of domestic violence, the programme this year included several significant events raising awareness and enhancing expert exchange. Whether these were events organized by non-governmental organizations, the Coordination-Methodological Centre for the Prevention of Violence against Women or the Programme Operator (PO), their common feature was strengthening multi-institutional dialogue and cooperation from an interdisciplinary perspective. In addition to the issue of violence in intimate partner relationships, the issue of sexual violence resonated more significantly this year. In 2023, it can be concluded that the issue of violence against women and domestic violence is no longer taboo. Dozens of articles have been published by the media devoted to this topic since January 2023. During the 16 days of activism against violence against women, the President of the Slovak Republic, Zuzana Čaputová, took over the patronage of several initiatives and activities organized as part of the programme, including Conference on domestic and gender-based violence and Synergy Network meeting 2023, which this year was organized by the Slovak Republic.

Despite the positive impact of the Programme "Domestic and Gender-Based Violence", the financial situation of women NGOs, including those providing specific services to women experiencing violence and their children, remains precarious [4]. The Norwegian Financial Mechanism is currently the primary robust source of financial support to an effort to set up a systemic approach to the elimination and



prevention of violence against women, including the network of counselling centres and women's shelters in Slovakia.

Outcome 1: Understanding of gender equality increased

Nine projects are being implemented under Outcome 1. One of them has successfully completed all its activities. Following a call for additional funding for the implementation of existing projects in the Domestic and Gender-Based Violence Programme (DGVDP call), three projects (DGV01003, DGV01004 and DGV01012) were recommended by the Selection Committee for support in gender equality component. The total amount of the increase was EUR 161 682.

As the lectures and campaigns are planned through the whole implementation period of the projects, just preliminary results of the baseline value of surveys can be presented now. The survey has been conducted by the Project Promoters. 63.22% of the population to be targeted by the awareness-raising activities within the projects have been favourable to gender equality. In a gender comparison, 71.69% of women are favourable towards gender equality as compared to 52.50% of men. 54.83% of the population have rejected gender stereotyping. Regarding students, 72.33% of them in targeted schools within the projects have been favourable to gender equality (in the case of women it is 82.18%, in the case of men it is 60.15%). 54.58% of students have rejected gender stereotyping.

Since the evaluation of the questionnaires is administratively demanding for the small organizations, the programme operator will request the final values of the baseline values of the indicators at the end of the projects' implementation together with the achieved values.

Number of institution active in the field of gender equality remains the same (MyMamy, OZ Žena v tiesni, EsFEM, Institute of Human Rights, InTYMYta, Risoto, Slovak national centre for human rights, Freedom of Choice, Union of Maternity centres). These are institutions directly supported in the Programme as a project promoter (PP) or project partner. As part of the implementation of their projects, the PPs establish cooperation with other organisations active in in field of gender equality, thanks to which they manage to increase the quality or the effectiveness of the impact of their activities.



For example, in the course of implementation, the DGV01010 InTYMYta project established cooperation with 11 institutions (out of a target of 20) with the aim of mutual cooperation in the field of human rights protection, education for respect and equality, in order to build a more open and tolerant society for all, through educational and awareness-raising activities and by promoting and facilitating an open dialogue between key actors.

So far, 26 awareness-raising campaigns promoting gender equality have been held (the Programme's target value is 15). The PPs organise campaigns on annual occasions (e.g. 16 Days of Activism against Violence against Women, International Women's Day or Roma's Day) or specifically targeted at different gender equality themes for particular target groups. The campaigns have a high impact and are successful, which is a result of the fact that advertising agencies in Slovakia are beginning to focus on socially responsible advertising communication.

In this context, it is worth mentioning the campaign of the DGV01009 Risotto - United for equality project. The PP developed a campaign for young people with the aim of increasing gender sensitivity and changing the usual ways of thinking based on prejudices and stereotypes. The campaign communicated the idea that "the world is unisex" with a reach of 42,694 and 1,187,092 impressions on social networks.

So far, the lectures specifically focused on gender equality have been provided in 129 schools (target value 89) in 25 districts. 23 of them are schools with MRCs (target value 30). The lectures are planned through the whole projects' implementation; the target value of this indicator thus can be met.

Projects working with Roma communities implement innovative tools for increasing gender equality in the Slovak context. For example, the DGV01005 project works in community centres with the Bible as an effective tool for eliminating pathological phenomena, including arranged child marriages, but also other forms of gender-based violence. The activity is a pilot test of education and training focused on values and living the sacred in everyday life. The activity draws on studies of feminist theology.

Outcome 2: Victims of domestic and gender-based violence protected and supported


Nine projects are implemented under Outcome 2. All of them are in their full implementation.

Following a call for additional funding for the implementation of existing projects in the Domestic and Gender-Based Violence Programme (DGVDP call), four projects (DGV02014, DGV03019, DGV03020 and DGV03021) were recommended by the Selection Committee for support in component focused on support of services for women/men/children experiencing violence. The total amount of the increase was EUR 441 838.

All projects have been successfully launched and continue to be implemented. Delays in the implementation of activities have occurred for projects that have investment costs. Specifically, these are the cases of projects that are renovating or expanding a women's shelter (DGV02017) or renovating their own premises (DGV03020). Complications have also been faced by the PP of project DGV02013, which faces the problem of filling the positions in the new counselling centres with female counsellors. This is because none of the candidates met the statutory qualification and/or length of experience requirements (Slovakia has long suffered from a shortage of qualified female specialist counsellors because there is no formal training in this much-specialised profession. The demands on counsellors, which are anchored by legislation, do not reflect this situation.).

All projects continue to provide help, support and counselling services for women with experience of violence and their children. So far, services have been provided in 1,806 cases, of which 1,475 cases were provided directly to women, 139 cases to men and 192 cases to an unspecified person (in most cases to children). The target value is exceeded even though the target values for the indicators Number of existing counselling centres supported and Number of existing shelter places supported will not be met.

No new places have yet been created within the women's shelters. This is due to delays caused by the repeated tendering process for the reconstruction of the shelter building. Renovations started in October 2023, it is anticipated that successful completion will be achieved.



As part of their projects, the PPs develop educational and awareness-raising campaigns on various topics (7 out of 10). The elaboration of the campaigns is of a high standard, which is the result of the long-standing involvement of feminist organisations and their cooperation with advertising agencies. The latter have a relatively high sensitivity to the topics and, in cooperation with counselling centres, produce campaigns that can be compared with world standards. The campaigns often work with the sub-topic of gender-based violence against women. The indicator will be met.

An example is the DGV02014 project campaign, which aimed to address a new form of violence against women, cyber/stalking. The aim of the campaign was to reach out to women so that they could identify themselves and know where to turn. The campaign had a high social following: a reach of 900,000 views. The PP reported an increase in calls to the help line in this context.

Together 15 counselling centres and women shelters meeting the European standards are involved in the projects. At the end of the Programme implementation, 20 counselling centres should meet the European standards.

The target values of the indicators Number of shelters and counselling centres enhanced in terms of children needs (16 out of 43) and Number of services providers running or participating in a consortium with public institutions at local level (12 out of 43) will not be achieved because the PO's expectations were too high. There are not so much organizations in Slovakia to be supported and not enough applications were submitted. However, all the counselling centres and women's shelters involved in the Programme continue to work on their enhancement in terms of children needs.

Outcome 3: Response systems to victims of domestic and gender-based violence improved

Under outcome 3 the predefined project (PDP) of the Institute for Labour and Family Research "Improving the victim-oriented approach – a tool enhancing the capacity to fight violence against women and domestic violence" continued with the implementation.

The most significant changes in the project budget in 2023 were made in connection with the expansion of the project to include a new activity, namely the operation of the National Helpline for Women with Experience of Gender-Based Violence. The amendment was concluded to the changes, increasing the budget lines as follows:

- expenses related to the National Hotline for Women with experience of gender-based violence for EUR 245,170
- expenses in connection with the increased costs of the budget item Costs for lecturers of programs for offenders of project partner 03 General Directorate of the Corps of Prison and Judicial Guard in the amount of EUR 5,980
- expenses in connection with the coverage of increased prices of building modifications, technical equipment of project partner 04 Ministry of the Interior of the Slovak Republic for EUR 30,352.

Since July 2023, a new activity - The National Line for Women Experiencing Violence has been implemented. For six months, The National Line for Women Experiencing Violence (NLW) has been operated within the project 24/7 within the operation of the Coordinating-Methodological Centre for the Prevention of Violence against Women (CMC). The NLW counsellors have provided support to 238 women experiencing gender-based violence; out of this number, 205 were asking the NLW for help, consultation, professional advice, and contacts, but also emergency intervention, calling the police or social services, for the first time. The line also assisted 33 women experiencing gender-based violence who had used the line's services in previous months (or even years) and needed to consult their situation again. The line is also contacted by relatives or friends of women experiencing violence (130 people), men experiencing intimate partnership violence (16 men), or women who experienced another type of violence (60).

In 2023, the CMC's regional coordination and methodological teams operated in all 8 Self-governing Regions in Slovakia. They maintained a network of helping entities through working meetings and participated in coordination meetings organized by other stakeholders. At the beginning of the year, the coordinators collected data from the organization that provides counselling and accommodation services for women experiencing violence for



monitoring purposes based on the methodology for collecting administrative data on partner violence against women in social services. The coordinators of the Nitra and Bratislava regions cooperated with the self-governing regions to create new regional action plans for preventing and eliminating violence — both were approved and published. Within the regional coordination, training aiming to enhance the situation of children witnessing violence against women has been organized for school psychologists, and training of police dedicated to the prevention and protection of sexual abuse of children has been delivered as well.

As the previous year, the CMC had a visible presence in the media. In addition to media communication and communication on social networks, the CMC and the Office of the President of the SR organized a discussion with high school students at the Business Academy in Bratislava, in which President Zuzana Čaputová also participated. Two lectures for university students also fuelled the primary prevention pillar: "Violence against Women" and "Social Work with Women Experiencing Violence". Another five workshops for high school students: "Consent = You are OK", targeted the prevention of gender-based violence with a particular focus on the prevention of sexual violence. One hundred forty-one young people participated in these workshops accompanied by supporting material – the "Consent = You are OK" leaflet.

The all-day workshop "Sexual Violence: Prevention & Help for Survivors", organized by the CMC as part of the Synergy Network Meeting 2023, was devoted to the issue of sexual violence and the possibilities of protection and support for its victims and experts from the countries of the EEA attended it.

In 2023, CMC, in cooperation with Anasoft Litera, prepared and made available to the public an educational website specifically aimed at preventing sexual violence https://www.nenamotajsa.sk/, which provides information for potential victims of sexual abuse and violence, parents of children at risk and experts on the risks and manifestations of grooming, as well as the possibilities of protection and support for victims.

So far, 50 (18 in 2023) lectures and consultations have been provided to supporting professions.

In 2023, the Academy of Police Force in Bratislava implemented a specialized course for domestic violence investigators. In 13 courses, 131 police officers were trained. The Prison and Court Guard Service has finished one introductory course of personnel for working with perpetrators, where 31 people were trained, and two training pieces for the program for perpetrators, where 15 lectors were trained. They have started with the implementation of programs for perpetrators at Correctional facilities. The seminars organized by CMC on Working with a child experiencing domestic violence has been attended by 35 professionals.

An educational programme for attorneys at law aiming to enhance their knowledge and skills while providing legal representation to child victims of sexual abuse and violence has been attended by 35 participants. The total number of professional staff trained is 2 110.


Since 2023, at least two specialized investigators have been working in 27 district units of the Police Force investigating violent crimes.

Five rooms in the police stations have been customized to the needs of victims of domestic and gender-based violence in 2023, and 3 rooms are in the process of completing construction work.

The research activities continue with the Norwegian partner aiming to take a closer look at the situation of women and children who live in women's shelters. Forty-nine interviews with women and children have been conducted using the same methodology in both countries. By the end of 2023, the CMC's experts were coding and analysing 28 interviews with Slovak women and six children—other interviews with children will be conducted next year.

Based on the research results, recommendations for institutions active in domestic and gender-based violence area will be elaborated and disseminated. An in-depth analysis is also going to be carried out in 2024.

In 2023, in connection with the cancellation of the PDP 2 Sexual Assault Centre, the reallocation from the Programme in amount of EUR 1 200 000, including national co-financing, was approved. The Memorandum of Understanding on the Implementation of the Norwegian Financial Mechanism was amended as of 17 February 2023, decreasing the grant for the Domestic and Gender-based Violence Programme to EUR 7 980 000.



Bilateral Outcome: Enhanced collaboration between beneficiary and donor state entities involved in the programme

In cooperation with a Norwegian partner, there are 3 projects implemented – predefined project DGVPP002 and two projects focused on gender equality, DGV01004 and DGV01010. In the project DGV03019 the Norwegian organization Alternative to Violence is a cooperating organization.

The partnership of the CMC within the predefined project DGVPP002 with the Norwegian Centre for Violence and Traumatic Stress Studies started in 2015 and currently focuses on research activities. The purpose of the project is to develop further research on shelters in Norway, including a comparative study with the situation in Slovakia. The research project consists of three different parts: children and young adolescents seeking support from shelters, mothers (and sometimes fathers) in contact with shelters and the societal role of the shelters. The Norwegian and Slovakian parts of the research are autonomous and are structured in slightly different ways. For both studies, the researchers will use qualitative in-depth interviews with parents, children and adolescents, and will also interview the staff working at the shelters. Till the end of 2023 the collection of data concerning children and young adolescents who seek help from domestic violence in shelters in Norway and Slovakia was concluded as well as most of the interviews with mothers and employees in the shelters were carried out. The research is in the final phase.

In the project DGV01004 Gender Equality Promotion (GEP), there is the Norwegian partner KUN involved. In order to transfer know-how and increase PP's professional capacities, experts from the partner organisation (Arni Hole, Karin Hovde) participate in regular online project meetings, provide consultation on the public campaign in the form of feedback on texts, content and influencers, and take an active part in the preparation of promotional material and background material for the new videos.

In DGV01010 project 34all (three for all) - "Three substantial messages on comprehensive sexuality education and sexual and reproductive health and rights for each target group" the Norwegian organization Sex og Politikk is involved. The Norwegian partner shared with the beneficiary the essential know-how, expertise and knowledge of a well-functioning organisation with more than 50 years of experience and provided feedback on the online content produced (methodologies, lesson plans, worksheets, role-plays...) in the framework of the project "Three Important Messages on Comprehensive Relationship and Sexuality Education and Sexual Reproductive Health and Rights for Every Target Group"). 3 good practice examples were transferred from Norway to Slovakia, which inspired the beneficiary to introduce the format of the Healthy Relationship Day, to cooperate with the municipality and to deliver the training also to public administration staff/women.

In the project DGV03019, where the Norwegian organisation Alternative to Violence (ATV) is a cooperating organization. ATV entered the project through expert Barbara Jacobsen in June 2023 as part of the workshop "Violence can be stopped". The recipient uses the available resources of ATV, which it implements in the development of an information campaign and in the further training of collaborators in order to achieve accreditation to help victims of violence and, above all, to provide the best possible services to clients, including children. ATV serves as an example of good practice in systemic cooperation with the state in assisting victims, working with batterers and in the preparation and implementation of relevant legislation on the subject. The beneficiary expects to continue cooperation with ATV after the project is completed.

In 2023, the DGVBF04 call was closed. Under this bilateral call DGVBF04 on strengthening the bilateral relations between Norway and Slovakia through activities such as networking, exchanges, sharing and transfer of knowledge, technology, experience and best practice between the Slovakian and Norwegian entities active in the field of domestic and gender-based violence there was one application submitted and approved. The approved initiative aims to both strengthen bilateral relations between the Norwegian Partner Reform and the beneficiary Human Rights Institute, as well as introduce Reform, its work, experiences, know-how, approaches and best practices to professional public through online participative workshops and wider public in Slovakia through social media platforms. The Norwegian Partner provides expertise through online workshops with the topics: 1. Reforms work, approaches and experiences, 2. Family politics, 3. Gender based violence and 4. Gender segregated labour market.

Slovakia has demonstrated commitment to the <u>SYNERGY Network</u> against gender-based and domestic violence throughout 2023, both through participation in meetings of the pan-EEANG Network, and also in sponsoring a



SYNERGY Conference and meeting in Bratislava. The PO participated in a <u>conference</u> for members of the SYNERGY network, organized by the European Institute Foundation, the Norwegian Ministry of Justice and Public Security and the Council of Europe on 15-16 June 2023 in Bulgaria. The aim of the conference was to promote a cross-cutting understanding of violence against women and domestic violence and to specify measures to facilitate <u>Roma women's access to justice</u> when they are victims of violence. At the same time, the conference also addressed the improvement of <u>current and future initiatives</u> within the programmes funded by the EEA and Norway Grants Mechanism that address the topic of domestic and gender-based violence.

The Slovak Republic hosted a SYNERGY conference meeting on 6-8 December 2023. The conference on the topic "Support for services to victims of domestic and gender-based violence – way to results and sexual violence" was organized by the Ministry of Investments, Regional Development and Informatization of the Slovak Republic in cooperation with the CMC and Ministry of Labour, Social Affairs and Family of the Slovak Republic. The conference was prepared and realised with the excellent support and cooperation of the Council of Europe and the Helsedirektoratet. The aim of the conference was to discuss the needs of support and specialised services and how to sustain those needs and to share experience and build knowledge on wide range of issues concerning the support services provided for the survivors of domestic and gender-based violence in Europe, with a focus on sexual and intimate partner violence. Conference attendees had an opportunity to join the "Blow the Whistle" initiative organized in order to raise awareness about the violence women and girls experience during their lifetime. There was also an option for projects site visits in Nitra and Bratislava. The conference was opened by the President of the Slovak Republic Zuzana Čaputová, who also took over the patronage. During the conference, the best practice from Norway was transferred in the field of specialized support services for survivors and in the concept of consent in primary prevention of sexual violence or in the topic of uncertainty, misunderstandings and negotiating consent among Norwegian youth. The Council of Europe provided insight into European standards and promising practice from implementation of the Istanbul Convention, specifically as regards specialised support services, sexual violence and reporting violence against women. The feedback on the topics and results of the conference was very good both from the Slovak participants and from participants from abroad. Similar events are welcomed by Slovak NGOs as they are important in terms of sharing and networking.

The Programme also contributes to strengthening of bilateral relations between the donor and beneficiary countries by the excellent cooperation with the Helsedirektoratet - the Donor Programme Partner (DPP), the Council of Europe as the International Partner Organization (IPO), CMC, PO and the Ministry of Labour, Social Affairs and Family of the SR (the members of the Cooperation Committee). In 2023, the DPP and IPO monitored the progress in the Programme and provided strategic advice on domestic and gender-based violence and support to the Programme, including providing CoE resources and expert advice on data collection, support for hotline workers working with victims of sexual violence, and perpetrator programmes, advice on the call for additional activities and/or price increase and on the preparation of SYNERGY network meeting conference. Further, the CoE provided a Slovak translation of the CoE Recommendation on protecting the rights of migrant, refugee and asylum seeking women and children.

C. MONITORING AND EVALUATION


1. Monitorings carried out

In 2023, regular monitoring, including site visits, was carried out in addition to the review of interim project reports that assess project progress every four months, including telephone and email communication with the PP. Within the gender equality projects, monitoring of compliance was carried out on project DGV01007 and monitoring of results on project DGV01012. Within the projects focusing on domestic and gender-based violence, 3 results monitoring exercises were carried out on projects DGV02017 and DGV03019 and 2 compliance monitoring exercises on projects DGV02018 and DGV03021.

The projects on gender equality are being implemented in slight delay. In the DGV01007 project, there is a risk of not meeting the specific indicator for the number of students to receive lectures (1 500).

Within the project focused on domestic and gender-based violence, there are some project in slight delay; however, there are no doubts about their successful implementations by the end of eligibility period.

No further monitoring visits are planned for 2024. The monitoring visits that took place in 2023 will be completed.



2. Evaluations carried out

The evaluation is not planned in the programme, as it will be carried out by the National Focal Point in 2024.

Annex 2: Communication summary

1. Best projects

The **DGV01009 project** is one of the best examples of good practice in adapting educational activities to the target group, in this case the new generation of young people, in an interesting and attractive way.

Within the educational activities, the project responded to a new generation of young people who are characterised by a different communication style, as they are the first generation to grow up in the era of smartphones and social media. Their preferred communication medium is no longer email, but something instant: Messenger, WhatsApp, Snapchat or Instagram. The attention span of these young people has dropped to 8 seconds and on average they receive 3,000 messages a month. This makes young people less focused. However, they are also better multi-taskers.

The format of audiovisual lectures proved to be an effective and innovative method of informal education of students, as the dynamics of the lecture corresponds to the current rapid trend in the lives of young people - living in a world of constant updates. Audiovisual lectures take advantage of young people's ability to take in a large amount of information and stimuli at the same time.

The aim of the activity was to raise awareness on gender equality. Using short excerpts from films, TV series and commercials, the lecturer and lecturer explained negative stereotypes about women and men in public and private life, highlighted the importance of women's representation in decision-making at all levels of society, and the importance of equal opportunities for women in accessing and controlling economic resources, including fair pay and sharing domestic responsibilities.

The dynamics of the audio-visual lectures are enhanced by the fact that the male lecturer guides the short excerpts from films and TV series, whose speech replicates the fast-paced communication of the young generation, while the female lecturer in turn slows down and anchors the individual excerpts in theory. The number of audiovisual demonstrations in one lecture does not exceed 70 in 90 minutes.

Project DGV01010 is a unique and very important project in Slovak conditions, which conceptually deals with complex relationship and sexual education and sexual reproductive health and rights. The project was implemented in cooperation with a Norwegian partner, which contributed its good practice.

The current situation in Slovakia is currently generally unfavourable on the topic of gender equality and access to reliable information on relationship and sexuality education and sexual and reproductive rights and health. Political campaigns based on the slogan "We have stopped the Istanbul Convention", the constant tabling of bills to tighten abortion, the rhetorical formulation of the term "culture of death" "gender ideology" and the distortion of the meaning of gender and sex limit the fundamental human rights to access to information, health care, dignity and privacy.





To this end, the project has developed freely available materials on CSCV and SRHR for youth, teachers, and parents that promote evidence-based and research-based information. At the same time, content was prepared for the association's website to serve as a first point of contact for those interested in the issue.

With its outputs, the project is a pioneer in the conceptual approach to relationship and sexuality education and sexual reproductive health and rights in Slovakia.

The **DGV02014** project focused on developing its services in the context of developing incidents of stalking and a new form of cyberstalking violence following the end of isolation after the COVID-19 pandemic. These forms of violence have recently begun to show increased to extreme levels of severity. Based on the women's accounts, the Recipient was aware that the continuation of violence in these alternative ways to control, coerce a return to the relationship, and/or retaliate even after the violent relationship has ended is severely and invasively interfering with the women's lives and preventing them from regaining a sense of safety and healing from the violence. The prepared campaign was also a response to the fact that stalking and cyberstalking make up an increasing proportion of cases in the long term and increasingly sophisticated forms of stalking and cyberstalking in particular are on the rise.

The awareness-raising campaign was prepared in cooperation with an advertising agency that has a gender-sensitive perspective and was able to grasp the topic creatively and sensitively. The awareness-raising campaign was carried out extensively on social media, where expert blog posts on stalking, cyberstalking and technological security were gradually published and promoted. There was a parallel communication with the media, followed by media outlets. The counselling centre was contacted by a higher number of women during the campaign period to ask for help and support in dealing with their situation. Based on the response of the women, the beneficiary decided to extend the duration of the campaign. The campaign showed a high level of effectiveness and, in particular, confirmed the extent of the existing problem of stalking and cyberstalking and the need to address them.

The campaign's main video had a reach of 900,000 views.

The success of the campaign, and specifically the main video, is evidenced by the fact that it was awarded the Bronze Golden Nail and three shortlists in the largest Slovak advertising competition Zlatý klinec in the social campaign categories.

2. Visibility of the Grants and the Donors

2.a. Communication activities

The PO proceeds in line with the Communication plan for the programme. The PO communicates its dissemination and publicity activities with Royal Norwegian Embassy to Slovakia and the Press Department of the Ministry of Investments, Regional Development and Informatization of the Slovak





Republic. Through the web site www.eeagrants.sk and Facebook profile https://www.facebook.com/EEANorwayGrants/ the PO communicates with general public and besides the basic information presents the programme activities and results. Information about the programme and projects implemented are published.

The Domestic and Gender-based Violence Programme webpage www.norwaygrants.sk/dgv is a subpage of the national single web page operated in Slovak and English. Within this page, 2 articles were directly dedicated to this programme in 2023. One of the articles were dedicated to the closure of the DGVDP call, second one to the predefined project and its bilateral research activity. The third article was dedicated to the process of public procurement within all programs.

Outputs, results as well as good practice within the supported projects were presented at the SYNERGY network meeting conference, which took place in Bratislava on 6-8 December 2023. The conference was attended by about 130 people from 18 countries. Two articles on the SYNERGY Network webpage were dedicated to GBV activities in Slovakia in 2023, and the Council of Europe's Gender Equality Division also featured two articles on Slovakia's work on violence against women and domestic violence. The Council of Europe's Directorate of Programme Coordination further featured an article on Slovakia.

2.b. Project stories

Activities on social media, precisely the Facebook page https://www.facebook.com/EEANorwayGrants/, in the programme DGV for the year 2023 focused on presenting individual projects, announcing their conferences, seminars and another online or in-person events. One of the most visible activities within this programme was connected to the 16 Days of Activism against Gender-Based Violence and Synergy Network meeting presented by Facebook campaign. Campaign was also joined by actresses from Slovak National Theatre, who also created a short video to support it. Overall, the programme DGV has earned on Facebook a number of posts (37), likes (801), comments (6) and shares (72) and had a significant reach of posts (9142) to individuals. Highly successful FB campaign on the occasion of 16 days of activism contributed to the total number by 29 posts, with 728 likes, 7 comments, 65 shares and reach of post 6570 to individuals. The post with the most likes (41) was a post from the first Day of Synergy Network Meeting 2023. The entire Synergy network meeting conference was streamed via the YouTube channel https://www.youtube.com/@grantyehpanorskanaslovensk3316/streams. The YouTube channel was also a carrier of promotional videos for individual projects of the DGV programme. The videos were also posted on the programme's website.
